The city's Comprehensive Plan is the basis for all land use planning and growth management actions in Lake Oswego. The Plan addresses everything from citizen involvement and economic development to transportation, natural resources, housing, and infrastructure.

The community is currently in year two of an update to the Plan. The Plan has been discussed at over 100 meetings and events! **Thanks to everyone who has participated so far!** In the first year the community developed a vision for Lake Oswego 2035. Now the Comprehensive Plan Citizen Advisory Committee is drafting revisions to the goals and policies in the Plan based on that vision and your feedback.

CONNECTED COMMUNITY Bike Ride



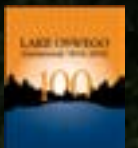
